Notes:

- 1. Subscription income in the financial year was about 15% less than that in the previous year. (Due to timing factors, this is not an indicator of membership numbers)
- 2. The continuing adverse impact from the suspension of lectures at the Embassy as a result of Covid related restrictions in the 2021-2022 year resulted in visitor fees banked during the year being 50% of those banked in the previous (2020-2021) year.
- 3. All functions, other than the Volunteers' Christmas Cocktails, are organised on a 'break-even' basis. There were a number of functions for which there were charges in the reporting period (including the 2022 Midwinter Lunch) but, apart from the final payment of \$1,700 for the Midwinter Lunch on 1st July 2022 not being invoiced until that day (and being the first payment of the 2022-2023 financial year), all income and expenditure relating these functions occurred in the 2021-2022 financial year.
- 4. This income is from members who made unnecessary payments and have chosen to not take up the offer of a refund.
- 5. As in the two previous financial years, several lectures at the Embassy were suspended (and presented via Zoom) for the Covid-19 lockdowns that took place during the financial year, significantly reducing expenditure.
- 6. The 2021- 2022 expenditure was for one instance where a lecture presenter requested a donation to a relevant charity be made in place of the gift of a book token, and another where a donation was made to a relevant charity associated with a person who provided services to U3A.
- 7. Expenditure in 2021/2022 is less than in the previous financial year during which the costs of a replacement computer for the front desk and relevant improvements to the associated programme were incurred.
- 8. Includes Paypal Charges of \$1,427.98 and Public Liability Insurance of \$711.85.
- 9. \$8,400 was transferred to the Westpac 01 a/c after balance date.
